3.) RELIGIOUS EDUCATION DISCUSSION

Susan Wheeler of the Parish staff gave a report regarding the new Religious Education program. The program will start on September 21, 2014. 4.) LETTER TO BISHOP

The letter involves the request of the parish that \$100,000.00 be transferred from the Bishop to our local parish account to be shared with the following organizations: San Miguel School (\$18,000.00); Xavier Clinic (\$23,000.00); Hope Food Pantry (\$44,000.00) and Catholic Worker House (\$15,000.00).

The Parish Council reviewed Father Austin's letter and approved sending the letter to Bishop Slattery by consensus.

5.) CARPET REPLACEMENT

Sharon Doty reported by e-mail through Ray Ruess that she discussed carpeting with an architect. The architect recommended that we use carpet tiles. The Parish Council referred the matter to the Finance Committee for bids.

6. LOOPING REPORT

Sharon Doty reported by e-mail through Ray Ruess that she discussed looping the church sanctuary for those wearing hearing aids with someone in that business. According to Sharon's source the church is not feasible to loop because of overhead lines.

The Parish Council received Father Austin's Social Justice Initiative document.
